



Warranty

CSS LIMITED WARRANTY:

All **Sirocco™** products are warranted by Cleaning System Specialists Inc. (CSS), to be free of defects in material and workmanship under normal use, for a period of **ONE YEAR** from the date of the original purchase. Items that fail due to normal wear on parts such as o-rings, hoses, seals, quick couplers, nozzles etc. or, damage resulting from neglect, abuse, tampering, or modification are not covered under this warranty. CSS will, at its option, repair or replace any part covered by this warranty which is defective under normal use for one year with no charges for parts or labor. All defects must be verified by an authorized CSS technician.

Exceptions to the one year warranty are for **PARTS ONLY**: Annovi Pumps: **FIVE YEAR** Warranty (**LIFETIME** Brass Manifold Warranty – Even against freezing); Heating Coils: **FIVE YEAR** Warranty.

LIMITATION OF LIABILITY:

CSS liability in all events is limited to, and shall not exceed, the purchase price paid for the equipment.
